Whereas, First party, second party and third party (herein referred to as
"party" individually and "parties" together) are desirous of establishing a legal
aid clinic to inculcate the spirit of social responsibility amongst students and to
ensure availability of justice to the poor downtrodden and weaker section of the
society.

6. The objectives of establishment of this clinic, as mutually agreed upon, is
as follows:-

- To provide legal services to the poor and weaker sections of the Society.
- To provide inexpensive local machinery for handling legal services of basic nature like legal advices, drafting petitions, notices, replies and other documents of legal importance.
- To resolve disputes of local people through mediation and conciliation and thereby preventing the disputes from reaching Courts.
- To conduct surveys on contemporary socio legal issues.
- To impart clinical education as part of practical training and also to imbibe the students to commit to social service to help the weaker sections of the society.

7. The Clinic shall functions on every second and fourth Saturday from 9.00am to 5.00pm of every month.



10 student volunteers will be selected to provide legal advices under the guidance of Faculty-in-Charge, as may be selected/ appointed by the parties.

9. The Clinic maintains records and documents of various activities conducted by the Clinic including the list of legal aid seekers, the type of service rendered, particulars of para Legal Volunteers, the personnel's from the Bar and all other related information.

10. Some of the important activities of the Clinic are enumerated periodically here in below.

- Participation of Co-ordinator and Students at Lokadalat Panel
- Jail Visit
- Socio-Legal Survey
- Essay Writing Competition
- Guest Lecture on Legal Aid and Legal services Authorities
- Legal Aid Camp
- Socio-Legal Survey
